2019 Water Quality Report for Superior Township

Water Supply Serial Number: 00880

This report covers the drinking water quality for Superior Township for the 2019 calendar year. This information is a snapshot of the quality of the water that we provided to you in 2019. Included are details about where your water comes from, what it contains, and how it compares to United States Environmental Protection Agency (U.S. EPA) and state standards.

Your water comes from 2 groundwater wells, each over 400 feet. The State performed an assessment of our source water to determine the susceptibility or the relative potential of contamination. The susceptibility rating is on a seven-tiered scale from "very-low" to "very-high" based on geologic sensitivity, well construction, water chemistry and contamination sources. The susceptibility of our source is very low.

There are no significant sources of contamination in our water supply. We are making efforts to protect our sources by well head protection program.

Contaminants and their presence in water: Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Vulnerability of sub-populations: Some people may be more vulnerable to contaminants in drinking water than the general population. Sources of drinking water: The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. Our water comes from wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture and residential uses.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.



In order to ensure that tap water is safe to drink, the U.S. EPA prescribes regulations that limit the levels of

certain contaminants in water provided by public water systems. Federal Food and Drug Administration regulations establish limits for contaminants in bottled water which provide the same protection for public health.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER Reporting Requirements Not Met for Superior Township

We are required to report the results of your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. While we collected our monthly total coliform sample on time, we did not report the results to the Michigan Department of Environment, Great Lakes, and Energy (EGLE) by the May 10, 2020, deadline for the April 1 to April 30, 2020, compliance period.

What should I do?

There is nothing you need to do at this time. This is not an emergency. You do not need to boil water or use an alternative source of water at this time. The results of the sample were negative for bacteria. Even though public health was not impacted, as our customers, you have a right to know what happened and what we did to correct the situation.

What happened? What is being done?

While we collected the sample on time, we inadvertently missed reporting the sample results to EGLE by the required deadline. We are required to monitor total coliform by collecting one sample per month. We collected the required sample on April 6, 2020, but failed to report the result until May 26, 2020. We are making efforts to ensure this does not happen again. We have already returned to compliance.
