PROHIBITION OF RECREATIONAL MARIHUANA ESTABLISHMENTS ORDINANCE

An ordinance to provide a title for the ordinance; to define words; to prohibit marihuana establishments within the boundaries of Superior Township pursuant to initiated Law 1 of 2018, MCL 333.27951, et seq., as may be amended, to provide for severability, to repeal all ordinances in conflict therewith and to provide an effective date.

ORDAINS:

SECTION I

This ordinance shall be known as and may be cited as the Superior Township Prohibition of Marihuana Establishments Ordinance.

SECTION II DEFINITIONS

Words used herein shall have the definitions as provided for in the Michigan Regulation and Taxation of Marihuana Act (Initiated Law 1 of 2018), MCL 333.27951, et seq., as may be amended.

SECTION III NO MARIHUANA ESTABLISHMENTS

Superior Township hereby prohibits all marihuana establishments within the boundaries of the Township pursuant to the Michigan Regulation and Taxation of Marihuana Act (Initiated Law 1 of 2018), MCL 333.27951, et seq., as may be amended.

SECTION IV SEVERABILITY

The provisions of this ordinance are hereby declared to be severable. If any clause, sentence, word, section or provision is hereafter declared void or unenforceable for any reason by a court of competent jurisdiction, it shall not affect the remainder of such ordinance which shall continue in full force and effect.

SECTION V REPEAL

All ordinance or parts of ordinances in conflict herewith are hereby repealed.

SECTION VI EFFECTIVE DATE

This ordinance shall take effect on October 11, 2019.
