## ORDINANCE NO. 9.A.

An Ordinance for the creation of a Water and Sewer Department

SECTION I. The administration, management, supervision and control of the public water supply system and the public sewage collection and disposal system for the Township of Superior shall hereafter be under the direction and control of and be administered by the Superior Township Water and Sewer Commission, to be established and maintained in accordance with the provisions of this Ordinance and the said Commission shall employ a superintendant and employees as may be necessary to efficiently operate said systems.

SECTION II. The Superior Township Water and Sewer Commission shall be
composed of three (3) members who shall be appointed by the Township
Board for terms as shall be established by said Board. The members of the
Water and Sewer Commission shall be residents of the Township of Superior
and shall be paid at a rate of Twenty Dollars (\$20.00) per meeting, not
exceeding meetings per fiscal year. The Water and Sewer Commission
shall meet:
Time: 7:30 P.M. Place: Township Hall or other designated
Place
Frequency of meetings: To be set later

SECTION III. The Water and Sewer Commission shall select a Chairman who shall chair their meetings and a Clerk who shall take accurate minutes of said meetings. Said Commission shall develop rules and regulations for the use of the sewer and water systems of Superior Township. Said rules and regulations shall be effective only after they are reviewed and approved by the Township Board and published once in the local newspaper and posted in the Township Hall.
