Section 11.04D, Regulations and Standards (p 79) o LOT AREA — Every lot occupied by a dwelling hereafter erected shall contain an area not less than 5 acres. If more than one dwelling is desired on a lot, the minimum lot area is 20 acres, o MAXIMUM NUMBER OF DWELLINGS —A lot meeting the 20 acre requirement shall contain one or two dwellings maximum.
