  - Motion by S. Kniskern and supported by J. Waisanen that the Parks Advisory Committee will not be compensated for their work on the committee. Motion passed unanimously.
  - Motion by S. Kniskern and supported by J. Waisanen that the Park Committee will be an Advisory Committee only. Motion passed unanimously.
  - Motion by S. Kniskern and supported by J. Harris that the Park Advisory Committee will not be required to follow the OMA as the committee is advisory only. Motion passed unanimously.
  - Motion by S. Kniskern and supported by J. Harris that the Superior Township elected board will review the Park Advisory Committee's recommendations. The Superior Township Board will make any final decisions regarding the Superior Township Park. Motion passed unanimously.
  - Motion by S. Kniskern and supported by J. Harris that the Parks Advisory Committee does not have any authority to approve contracts or expenditures. The Parks Advisory Committee cannot spend money. All purchases must be approved by the Superior Township Board. Motion passed unanimously.
