It further is ordained that the enforcement provisions of Public Act 230 of 1972 hereby are adopted by the Township of Superior

It further is ordained that the Township of Superior designates Chippewa County as the enforcing agency to discharge the responsibilities of the Township under this ordinance. It further is ordained that enforcement of the Michigan Electrical Code shall come and be in effect November 10, 1977.

All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed.

Should the courts declare any provisions or section of this ordinance unconstitutional or invalid, then such decision shall affect only the section or provision so passed upon, and shall not effect any other section or part of this ordinance.
